

Know all men by
these presents, that
I, Lewis Roberts,

and Nancy, his Wife, of the District and State afore-
 said, in consideration of the sum of two hundred Dollars to us in hand
 paid by Jacob Reese, of the said State and District, have granted, bar-
 gained and sold and released and do hereby grant, bargain and convey
 release and convey unto Jacob Reese all my interest off in or to in the Estate
 of Richard Roberts deceased, after the Widow shall take her one third part
 all the effects, (viz) two tracts of Land lying in Cherokee County, Alabama
 and one other tract in Green Bush County, Mississippi, of the Lands, Plan-
 tations belonging to the Estate of said Richard Roberts, deceased, with all and
 every buildings, slaves, servants, horses, cattle, mills, utensils, appurtenances,
 moneys, bonds, notes, or accounts, and things whatsoever therunto the Estate
 belonging or in any wise incident or appertaining to the said Estate
 to have and to hold for the consideration above all and singular my in-
 terest in the said Estate unto Jacob Reese his heirs and assigns for-
 ever. And the said Lewis Roberts and Nancy his Wife for themselves their
 heirs and assigns do covenant with the said Jacob Reese, that they the
 said Lewis and Nancy his Wife now are lawfully, rightfully seized and
 possess of and in one tenth part of the lands, plantations, buildings &
 slaves, servants, horses, cattle, mills, utensils, appurtenances, moneys, bonds notes
 and accounts and things whatsoever, after the widow shall take her one third
 part of the effects incident thereto the one tenth of all the remainder without
 any reservation, trust, limitation, use or restraint or things whatsoever to alter, change
 make void, lessen, incumber or determine the same. And that they the said
 Lewis and Nancy his Wife now have in themselves good right and full power
 and absolute authority to grant and convey the above with all its appur-
 tenances with all the interest of lands and moneys to the said Jacob
 Reese his heirs and assigns in manner aforesaid, and that they will at
 all times hereafter warrant, and defend all and singular the premises, moneys
 and appurtenances unto the said Jacob Reese his heirs and assigns and free
 from the said Lewis and Nancy his Wife or either of them and every other
 person or persons whatsoever. In testimony whereof, we have hereunto fixed
 our hands and seals this the twenty-eighth of May one thousand eight
