Now this Indenture witnesseth the that the said William Bramlett for and in consideration of the said Debt or sum payable as aforesaid to the said Joseph McMillan, Senior and for the better securing the payment thereof to the said Joseph McMillan, Senior, according to the tenor and effect of said Note aforesaid and also in consideration of the sum of One Dollar to the said William Bramlett by the said Joseph McMillan in hand paid at and before the sealing and delivery of these presents do grant, bargain, sell, alien, release, convey and confirm unto the said Joseph McMillan, Senior and to his heirs and assigns forever all that Plantation or tract of Land lying in Greenville District in South Tyger River and Mates thereof containing One hundred and twenty-eight Acres, bounded by lands of Joseph McMillan, Jr said William Bramlett & George Dill known as the plan of Bramlett bought Dennis Cram Together with all and singular the rights, members, and appurtenances therunto belonging or in anywise appertaining and the reversion and reversions, remainder or remainders, rents, issues, and profits thereof to have and to hold the said tract of land with the appurtenances unto the said Joseph McMillan, Senior, his heirs and assigns forever; Provided, always, nevertheless, and it is the true intent of the parties to these presents that if the said William Bramlett his heirs executors or adm'rs shall well and truly pay or cause to be paid unto the said Joseph McMillan, Senior the sum for which the said Note calls according to tenor and effect of the said Note above mentioned then and from thenceforth these presents shall be utterly null and void any thing herein contained to the contrary thereof in any wise notwithstanding. And it is covenanted and agreed upon by and between the said parties to these presents that until default shall be made in the payment of the aforesaid sum as before set forth and the interest for the same, it shall and may be lawful to and for the said Bramlett peaceably and quietly to hold, use, occupy, profess and enjoy all and singular the premises above granted and released and every part thereof with the appurtenances to have receive and take the rents, issues, and profits thereof to his own particular use and behoof any thing herein contained to the contrary thereof in any wise notwithstanding.
