This Indenture, made the seventeenth

day of July in the year of our Lord one thousand
eight hundred and forty four, between John A. Leland Superintendent of Pub-
lic Works, of the State aforesaid, of the one part, and of the other part:

Whereas, the said John W. Hodges stands indebted to the said John
A. Leland Superintendent as aforesaid by Bond for the sum of Seventy-
Three Dollars and twenty cents payable in three annual instalments,
with interest from the date thereof. That is to say, one third part with in-
terest, on the seventeenth day of July, 1845, one other third part, with inter-
est, on the seventeenth day of July, 1846, and the remaining third part, with
interest, on the seventeenth July, 1847.

Nor this Indenture witnesseth, that the said John W. Hodges, for and
in consideration of the said debt or sum, payable as aforesaid to the said
John A. Leland Superintendent as aforesaid, and for the better securing
the payment thereof, to the said John A. Leland, Superintendent afores-
aid, and also in consideration of the sum of One Dollar by him the
said John A. Leland Superintendent as aforesaid to the said John W.
Hodges in hand paid at and before the sealing and delivery of these pre-
sents, do Grant, Bargain, Sell, Alien, Release, Convey and Confirm unto
