and release, unto the said John R. Symes, All that plantation or
tract of land situate lying and being in the District and State
aforesaid, on the waters of Enoree River, beginning in a stone corner,
thence S. 71. E. 9 ch. 80. to a post oak - thence S. 8 E. 40 chains to a
post oak - thence N. 75 E. 23 ch. to a Hickory - thence S. 84 E. 31
ch. to a post oak - thence S. 50 1/2 W. 22: 00 to a Red oak - thence
S. 26 W. 21. 25 to a dogwood - thence N. 62 W. 45 ch. to a post oak -
thence N. 10 ^{prop. line} W. 13 ch. to a white oak sapling, thence along Rosemond's
line, as sold by me to the said Rosemond to a stake corner, and
from the stake corner to the Rutherford Road - thence along the
Rutherford Road to a black oak tree - and from thence to the
beginning stone corner - containing in the whole Three hundred and
thirty-five acres be the same more or less - Together with all
and singular the Rights, Members, Quitclaims and Appurte-
nances to the said Premises belonging, or in anywise incident or
appertaining: To have and to hold, all and singular the
Premises beforementioned, unto the said John R. Symes, his Heirs
and Assigns forever. And I do hereby bind myself and my Heirs,
