 Wynne of the same state and district, have granted, bar-  
 gained, sold and released, and by these presents, do grant,  
 bargain, sell and release unto the said Robert Wynne,  
 his heirs and assigns forever a certain Tract of Land,  
 containing three hundred and thirteen acres, (more or less),  
 situate in said district on the waters of Langston's Creek  
 of Rudy River, and hath such bounds, marks &c as fol-  
 lows viz. Beginning at a Red oak stump 3x on S. W.  
 Charles' line thence N. 22 E 50 chs. to a stake 3x thence N.  
 49 W. 32.75 chs. to a stake 3x thence N. 30 E. 14 chs. to  
 a small Blk. oak 3x near the head of a branch, thence S.  
 47 E. 1.50 to head of branch and down the meanders  
 of said branch to a stake 3x at the junction of said  
 branch and another, thence S 81 E 46 ch to a stake 3x  
 on a branch, thence down said branch S. 50 chs. to a  
 stake 3x thence S. 51 W. along an old fence road 10 chs to a  
 stake 3x thence S. 58 W. 4.50 chs. to a stake 3x in the mid-  
 dle of an old road, thence on said road S 2 E. 2.50 chs to  
 a stake on a ditch, thence down said ditch to its junc-  
 tion with another ditch, thence down the main ditch about
