sold and released and by these presents do grant bargain sell and re-
lease unto Minor C. Lankford of the same state and district all my
interest in a certain tract or parcel of land (it being one half of said
Tract) situate also in the same state and district on both sides
of Mottows creek branch - waters of Creek Packetelle River. Beginning
on a black oak on the south side of said creek running thence $W 14^{\circ}$
 $W 83$ chains crossing the side creek to a pine thence $875^{\circ} E$ 28 chains
crossing a branch to a Post oak thence $W 38^{\circ} E$ 8 chains to a black
oak on the road thence $S. 6^{\circ} E$ 75 chains to a black oak thence $S.$
 $61^{\circ} E$ 15 chains to the begining containing one hundred and thirty
five acres be the same more or less to have & to hold all and sin-
