Elford Esquire of Greenville my true & lawful attorney and as my agent to represent me as Trustee & in conjunction with the attorney and representative of the said Daniel Jenkins as Trustee to ascertain the amount of the several Judgments & Guaranties afore mentioned and then in order to pay the same to sell or cause to be sold in the most advantageous terms for the above purpose The plantation called Chesnut Hill situated in _____ with these three Slaves Andrew Sharper & Abram and the furniture of the said Trust Estate in Greenville with power also to make & execute in conjunction aforesaid all necessary deeds and titles for the conveyance of the said property to the purchasers thereof and with the proceeds of such sale to pay or cause to be paid the Judgments and Guaranties aforesaid, and after such payments to take from the creditors or Plaintiffs of such Guaranties & Judgments assignments thereof to Francis L. Rous & Daniel Jenkins Trustees of Robt L & Isabella C. Baker in order that they may be indemnified for such payments and lastly to make all such arrangements & do all such acts in the premises as are necessary and proper to the fulfilment of the purpose of this Deed & as fully & effectually as if I myself was present & directing the same.
