



Edward Powell & Benjamin Polling To Booker Bomar.	Deeds 256 Acres Land.

Greenville District: Know all men  
by these presents that we Edward  
Powell and Benjamin Polling of  
the District and State aforesaid for

and in consideration of the sum of Eight Hundred dollars to Ed-  
ward Powell in hand paid by Booker Bomar of Spartanburg Dis-  
trict Have Granted Bargained sold and released and by these pre-  
sents do Grant bargain sell and release unto the said Booker Bo-  
mar all that tract or parcel of land situate lying and being  
in the District and State aforesaid on the head waters of Enoree  
river it being part of a tract of land formerly owned by Major  
Thomas Benson containing Two Hundred and fifty six acres Begin-  
ning at a stone near a Post Oak station in an old field running S  
27 1/2 E 23.20 to a stake on Marricks line thence N 83 E 28 30 chs to a  
stake 3x om thence N 3 3/4 W 11.70 chs to a Red Oak 3x om thence S 12 3/4  
E 32.50 to a small Post Oak 3x om near a Red Oak 3x om thence N 2  
E 18.00 to a stake 3x om thence 29 3/4 W 55.70 chs to a stone on Lynch-  
es line thence S 6 1/4 W 31.10 to a stone thence S 28 3/4 E 18.50 to a  
Spanish oak 3x new thence S 16 1/2 W 7.30 chs Red Oak 3x new on  
the edge of the road thence S 68 W 18.15 chs to the beginning  
corner reference to a plat made by Washington Taylor January  
28<sup>th</sup> 1847 will more fully appear.

acres acres of land around it which Benjamin Polling and my-  
self claims Equal shares in Together with all and singular the  
rights members Hereditaments and appurtenances to said Prem-  
ises belonging or in anywise Incident and appertaining To have and  
to hold all and singular the before mentioned premises unto the said  
Booker Bomar his heirs and assigns forever we do hereby bind our-  
selves our heirs Executors and administrators to warrant and forever  
defend the above mentioned premises unto the said Bomar his heirs  
and assigns against ourselves our heirs and against every other person  
or persons lawfully claiming or to claim the same or any part  
thereof. Witness our hands and seals this May 27 in the year of our  
Lord one thousand Eight Hundred and forty seven and in the Sev-  
entieth year of the American Independence.
