Lewis and Sarah Maria Lewis his wife, D. Miriam Mays, Samuel M. Earle and Edward H. Earle the legal Heirs and representatives of the late Judge P. J. Earle deceased for and in consideration of the sum of Three thousand Six hundred Dollars to us in hand paid by John T. Coleman the receipt whereof is hereby acknowledged Have granted bargained sold released and conveyed and by these presents Do grant bargain sell release and convey unto the said John T. Coleman all that plantation and tract of Land situate lying and being in the District of Greenville and State aforesaid Containing Three hundred and ninety five acres more or less: Beginning at a stake 3x near the Spring, thence S 81 N. 1. 60 chains to a stake 3x thence S. 19 E. 13 chains to a stake 3x thence N. 81 E. 1. 60 chains to a stake 3x thence S. 9 E. 17 chains to a stake 3x on the South side of the Augusta Road lately H. T. Thompsons corner now Mr. Peatties, thence with said Road S. 50 E. 6. 15 chains to a stake 3x thence S. 24 W. 7. 22 chains to a stake 3x H. T. Thompsons or Peatties Corner thence S. 11 E. 14. 20 chains to a pine 3x thence S 73 E. 13 chains to a stake 3x thence W. 18 1/2 E. 14 chains to a red oak 3x near said Road thence W. 61 E. 50 chains to a stake 3x thence N 29 W. 65. 60 chains to a stake 3x thence W. 64. W. 6. 50 to a stake 3x thence S. 75. W. 4. 20 chains to a red oak 3x thence S. 55. W. 15. 70 chains to a double poplar 3x thence S. 39 W. 2. 40 chains to a poplar 3x thence S. 89 W. 4. 75 chains to a poplar stump corner, thence W. 20 W. 9. 50 chains to a dogwood 3x and thence S 7 1/2 W. 36. 20 chains to the beginning corner being the same tract of Land except two acres sold to Henry T. And we and each of us do hereby bind ourselves jointly severally our joint and several Heirs Executors Administrators and assigns to warrant and forever defend all and singular the premises above mentioned unto the said John T. Coleman his Heirs and assigns against ourselves and our Heirs and against every other person or persons whomsoever claiming or to claim the same or any part thereof.
