I now all month by these presents that we Robert
Pedee and Martin W Pedee of Greenville last
-well and State aforesaid for and in consideration
of the sum of Thirteen hundred Dollars to us in

done and paid by Moses T Fowler of the same place have granted, bargained, sold and
released and by these presents do grant, bargain, sell and release unto the said Moses
T Fowler all that plantation or tract of Land containing Two Hundred and Seventy
Five Acres more or less, situated and lying in the State and District aforesaid in the
waters of Baboons creek beginning on a Hickory 3X and running thence S. 2½ E
56.90 to a sassafras 3X bounded by the Old Indian boundary, thence N 55 E 23
to a Stake 3X thence South 24.50 to a Stake 3X thence East 16.50 to a Pine 3X bounded
by William Harrison thence North 49 to a Red Oak sapling 3X thence S. 89 ½ E
37.75 to a Stake 3X thence N 2½ W 17.10 to a W. Oak sapling 3X thence W 88 W
7500 to the beginning. Together with all and singular the rights, members,
heirlooms, and appurtenances, to the same belonging or in any wise incident or
appertaining, to have and to hold all and singular the said premises, unto the said
Moses T Fowler his heirs and assigns forever. And we do hereby bind ourselves
and heirs, Executors, and Administrators, to warrant and forever defend all and
singular the said premises unto the said Moses T Fowler his heirs and assigns
against ourselves, and our heirs and against every other person, whosoever lawfully
claiming or to claim the same or any part thereof.
