 in the State and District aforesaid in considera-

tion of the sum of Two hundred Dollars to me paid by Sanford Heaton of State  
 aforesaid and District of Anderson have granted, bargained sold and released  
 and by these presents do grant, bargain, sell and release unto the said Sanford Heaton  
 All that tract or parcel of land containing One Hundred Acres more or less  
 situated in State aforesaid and District of Greenville and a branch of the Cedar  
 shoal creek waters of Saluda River Beginning on a Pine 3x near the old  
 field, thence S. 57° E 15.90 to a Post oak 3x. near the branch, thence down the  
 head of said branch to a Spruce 3x thence S 78° W. 24.60 to a Stake 3x thence  
 N 57° W 31° to a Stake 3x thence W 76° E 34.60 to the beginning corner bounded  
 by lands belonging to aforesaid Cooley and David Vincent.

Together with all and singular the Rights, Members,  
 Hereditaments and Appurtenances to the said Premises belonging or in anywise  
 incident or appertaining. To Have and to Hold all and singular the Premises  
 before mentioned unto the said Sanford Heaton his Heirs and Assigns forever.

I do hereby bind myself my Heirs, Executors and  
 Administrators to warrant and defend all and singular the said Premises  
 unto the said Sanford Heaton his Heirs and Assigns against myself and against  
 every person whomsoever lawfully claiming, or to claim the same or any part thereof.
