Thence N 44 E. 3.75 to Black Gum dead. 3x 0. m on branch Thence N 57 W 17 chs to stake 3x 2 m Thence N 35 E a crop a branch 33.50 to Stake 3x bounded said Adam Jones. Thence S 78 E 2 chs to P.
