Deceased W. S. Glenn who intermarried with Nancy Smith daughter of the
 said Abraham Smith and who departed this life since the death of his father with-
 out issue being Joshua Smith and Stephen Smith sons of the said Abraham and
 Mitty Sheppard the daughter of the said Abraham Smith and her husband
 William Sheppard and John Ches P. Brockman Executor of the last will and Testa-
 -ment of Abraham Smith and Trustee for several of the Legates in said will
 Whereas the said Abraham Smith died leaving his last will and Testament duly
 executed in which he gave to his widow Elizabeth Smith during her life time
 certain property and after her death to be equally divided among his four children
 to the P. Brockman in Trust for Joshua Smith a Tract of land therein described
 also to the P. Brockman in Trust for his daughter Nancy afterwards Mrs Glenn
 and now deceased a Tract of Land containing about Two Hundred Acres and one negro
 woman named Mary and all the balance or remainder of his property both real
 and personal to be appraised and divided into four lots and drawn for by his four
 children And whereas the said Testator then directs that one of these lots shall be
 given to John Ches P. Brockman now in Trust for his daughter Nancy to permit
 the said testatrix Trust to receive the use of it during her life and after death
 to be equally divided amongst his children And whereas the said Nancy has departed
 this life without children leaving her husband W. S. Glenn living and all the parties
 above named being anxious to settle the said Estate in a friendly manner and
 without the cost and trouble of litigation

Now know all men by these presents that it is agreed
 between the parties above named as follows: The widow Elizabeth Smith is
 to be paid by Thomas P. Brockman Executor of the sum of Two Hundred dollars
 in full of her claim to the legacy bequeathed to her daughter Nancy Smith by the
