said Greeting Whereas by virtue of a Writ of Fieri Facias issued out of
the Court of Common Pleas held for the District of Greenville dated the sixteenth
day of November in the year of Our Lord One thousand Eight Hundred and
forty eight at the suit of J Potts to me directed commanding me that of
the goods and chattles lands and tenements of Allen Potts to pay the sum of
Thirty two dollars 33 pds Dollars damage and costs I have seized and taken of
the lands and tenements of the said Allen Potts all of his interest in all that
certain piece parcel and tract of land containing Three hundred acres situated
and being in the District of Greenville on the waters of Reedy River being the
tract whereon Jonathan Potts now lives

Whereas the said premises with their appurtenances since the day
by me made by virtue of the said Writ of Fieri Facias before mentioned have
been exposed to sale at publick vevue and purchased by David Hooke of the
District of Greenville for the sum of Twenty One Dollars being the highest
sum bidder therefor Now know ye That I Mathew Taylor Sheriff aforesaid
by virtue of the said Writ of Fieri Facias aforesaid to me directed and delivered
as aforesaid and by virtue of the Statute in such case made and provided and for
and in Consideration of the said sum of Twenty One dollars to me in hand paid
as aforesaid by the said David Hooke the receipt and payment whereof
I do hereby acknowledge have granted bargained and sold and by these pres-
ents do grant bargain and sell unto the said David Hooke his heirs and assign-
ees forever the said tract piece and parcel of land with its appurtenances and all
the Estate right title and interest which the said Allen Potts of right had
in or to the same To have and to hold the said piece parcel and tract of land
with its appurtenances unto the said David Hooke his heirs and assigns
forever as fully and absolutely as the said Mathew Taylor Sheriff might
could or ought to grant bargain and sell the same by virtue of the Statute aforesaid
