of the sum of One Hundred and Forty Six Dollars to me in hand paid by Jefferson Barton of the District and State aforesaid have granted, bargained, sold, sold and released and by these presents do grant, bargain sell and release unto the said Jefferson Barton a certain Tract or parcel of Land lying and being in the District and State aforesaid on branch waters of the South Fork of Tyger River beginning at a Post Oak 3x3x3 and running N 12 W 6.02 to a White Oak 3x Thence N 8 1/2 E 19.43 to a White Oak 3x on the South side of a branch Thence down the branch unto the meadow to a large Rock below the fork of said branch Thence N 79 W 17.90 to a Post Oak 3x Thence S 18 1/2 E 19.43 to a Post Oak 3x Thence N 86 1/4 E 12.70 to a Black Gum 3x Thence S 86 E 5.60 to the beginning Bounded by Land belonging to Lawrence Brooke. S Good till Jefferson Barton and myself containing Thirty Six and one half acres be the same more or less and hath such marks and form as a plat of the same will more fully represent
