sideration of the sum of One Hundred Dollars to me paid in hand by James Green
 of the said State have granted bargain sold and released and by these presents
 do grant, bargain sell and release unto the said James Green his heirs executors
 administrators and assigns a certain portion a tract of Land containing
 Twenty Six and Three quarters acres situated on Reedy River in said district
 it being part of the tract of Land I bought from JHC Green and hath
 such bounds &c as follows Beginning at a stone in the bottom Thence N
 80 E 1.50 to a stone at a house place Thence N 30 E 14.5 to a Pine & Thence
 N 62 W 3.60 to Pasture Thence A 42 W 5.25 to a pine Thence S 73 W 11.50 to a
 Persimmon Thence S 65 W 13.50 to a Maple in Branch Thence N 75 W 30 links
 to maple Thence N 16 E 1 chain to a chestnut Thence N 50 W 5.75 to a sassafrass
 Thence S 36 W 2 chains to stake in branch Thence down said branch to the
 beginning corner Together with all and singular the rights, members, funditions
 and appurtenances to the said premises belonging or in any wise incident
