and release unto the said John Adams a certain piece parcel of Land Situated lying and
being in the District and State aforesaid on Reedy River Beginning on a Hickory corner
on the original line on the West bank of Reedy River Thence running the original
line S 50° W to a rock corner Thence running the original line N 40° E to a black
Rock corner Thence running the original line N 40° E to Hugh Stoenches line
Thence with said Stoenches line to said river Thence down said river to the begin-
ning Together with all and singular the Rights, Members, Inheritances and Opportunity
to the said premises belonging or in any wise incident or appertaining To have and to hold
all and singular the premises before mentioned unto the said John Adams his heirs and
assigns forever And I do hereby bind myself my heirs Executors and Administrators
to warrant and forever defend all and singular the said premises unto the said John
Adams his heirs and assigns against me and my heirs or any person or persons
whomsoever lawfully claiming or to claim the same or any part thereof.
