To all to whom these presents shall come, I Massena Taylor Sheriff of Greenville District and State aforesaid send Greeting. Whereas by virtue

of a Writ of Fieri Facias issued out of the Court of Common Pleas held for the District of Greenville on the Fifth day of November in the year of Our Lord One Thousand eight hundred and forty nine at the suit of Barshelaw Co. & Williams Co. of Adm. for the use of O'Connell to me director commanding me that of the goods and chattels lands and tenements of Roy Mc Coy & Thomas Mc Carroll to say the sum of Eight Hundred and fourteen dollars damages and costs I have seized and taken of the lands and tenements of the said Roy Mc Coy all that certain piece parcel and tract of Land containing Two Hundred Acres more or less situated and being in the District of Greenville lying on the North Bank of Saluda River adjoining lands of Dr. Williams Joseph Bates and others.

And Whereas the said premises with their appurtenancy since the seizure by me made by virtue of said Writ of Fieri Facias before mentioned have been exposed to sale at public vendue and purchased by James West of the District and State aforesaid for the sum of Eight Hundred and Ninety Dollars being the highest sum that was bid theron Now Know Ye That I Massena Taylor Sheriff aforesaid by virtue of the said Writ of Fieri Facias aforesaid to me director and delivered as aforesaid and by virtue of the Statute in such cases made and provided and for and in consideration of the said sum of Eight Hundred and Ninety Dollars to me in hand paid or received to be paid by the said James West the receipt and payment whereof I do hereby acknowledge have granted bargained and sold and by these presents do grant bargain and sell unto the said James West his heirs and assigns forever the said tract piece and parcel of Land with its appurtenancy and all the estate right title and interest which the said Roy Mc Coy of right had of in and to the same To have and to hold the said piece parcel and tract of Land with its appurtenancy unto the said James West his heirs and assigns forever as fully and absolutely as I the said Massena Taylor Sheriff aforesaid might or ought to grant bargain and sell the same by virtue of the Statute and the said Writ of Fieri Facias or otherwise.
