

Henry Sherman To	Mortgage of
Mr J Hudson	Slave

State of South Carolina

When all men by these presents That I Henry Sherman of Greenville District in consideration of One Dollar to be paid by Mr J Hudson in the District of Greenville in the State of said the receipt whereof is hereby acknowledged do by these presents bargain, sell and deliver unto the said Mr J Hudson a certain female slave named Sarah about Twenty Two years of age and her infant child called Phillis about four months of age To have and to hold the said Negro Slaves and the future issue of the said Female unto the said Mr J Hudson and assigns And I the said Henry Sherman for myself and each and every of my Heirs Executors and Administrators, the said Negro Slaves together with the future increase of the said Females unto the said Mr J Hudson and assigns do hereby warrant and defend

Provided Always That if I the said Henry Sherman and my Heirs Executors or Administrators shall pay unto the said Mr J Hudson or his assigns the full sum of Four Hundred dollar together with the interest due thereon at the times and agreeable to the terms contained in a certain Note or obligation bearing even date with these presents the said Mr J Hudson and given by me to the said Mr J Hudson as a security for the payment of the said sum of money and interest accruing thereon Then this Bill of Sale to be void or else to remain in full force But if default shall be made in the payment of the said sum of money and the interest in manner aforesaid that then it shall be lawful for the said Mr J Hudson or assigns to go or send with proper authority to any spot where the said negro may be to seize and take them into possession and to sell and dispose of the said negro Slaves as he or they shall fit and then to pay to himself or themselves such sums of money as shall then remain due with the charges arising by such seizure and sale And the receipt (if any) shall be rendered to me or my Heirs Executors or Assigns
