Together with all and singular the rights members hereditaments  
 and appurtenances to the said premises belonging or in anywise incident appertaining  
 To have and to hold all and singular the premises before mentioned  
 unto the said Gruy Hopkins his heirs and assigns forever And I do hereby bind  
 myself my heirs Executors and administrators to warrant and forever defend all and  
 singular the said premises unto the said Gruy Hopkins his heirs and assigns against  
 myself and against every person whomsoever lawfully claiming or to claim the same
