 said State and District a plantation or tract of Land lying on a branch of Needy  
 River in the State and District of said Beginning on a Post Oak 111 x Thence South  
 65 1/2 West 33 chs to a stone corner x Thence N 24 1/2 E 44.66 to a Stake 111 x (formerly dog  
 wood Thence South 65 1/2 E 54.66 to a Stake 111 x (now a red oak bush) Thence South  
 26 1/2 West 44.66 chs to the beginning corner, containing Two Hundred and Thirty two  
 acres be the same more or less To have and to hold Together with the all and sin-  
 -gular the rights members and appurtenances whatsoever to said Land belong or in anywise  
 appertaining thereto This being part of a survey granted to James Cook the 24<sup>th</sup> tenth  
 day of July One Thousand Seven hundred and eighty four And transferred by several  
 conveyances to me And I hereby bind myself my heirs Adm<sup>r</sup> and assigns Against myself
