T. Potts Thence N 18 E a long a line run for Epphain Ellis March 15th 1786 to a Spanish oak Thence N 50 W 20 to a stake Thence along said Ellis line S 30 W to a conditional Chestnut corner made between Jonathan and H. T. Potts Thence down the ridge a conditional line to a Hickory Thence down the ridge to a Blazed white oak Thence to a Blazed Hickory Thence along Young Potts line one made between Jonathan and Young Potts to the creek Thence across the creek Thence a straight front line to the beginning Hickory on Ellis line it being a part of a Tract of Land surveyed for Epphain Ellis and Grant to Colcock
