to me paid by Shanton P Poole of Greenville District in the State of South Carolina the grantee, bargain, sold and released and by this presents do grant bargain, sell and release unto the said Shanton P Poole all and singular my right title interest, claim and estate of in or to a certain Tract or parcel of land Situated in Greenville District in the State of South Carolina on both sides of Panthers Fork of Muske Cocha and of Tyas River containing Two Hundred and Sixty Two acres more or less being as follows, beginning on a White Oak Neighbors corner Thence S 25 W by chains 40 Links to a Spanish Oak Thence S 32 E 33 chains to a Red Oak Thence N 46 E 70 chains to Salmons Crock Line Thence N 65 W to a Red Oak Thence the same courses of said line to the beginning the same being part of a Tract of Fifteen hundred and Twenty Acres, granted to George Salmons the 3. day of April 1787

Together with all and singular the Rights, members, Rents, tithes and appurtenances to the said premises belonging or in anywise incident or appertaining unto the said Shanton P Poole his heirs and assigns forever

And I do hereby bind myself, my heirs Executors and Administrators to warrant and forever defend all and singular my right title interest claim and estate in the said premises unto the said Shanton P Poole his heirs and assigns against me and my heirs and against every other person lawfully claiming or to claim the same in any part thereof
