of land of same containing Four Hundred and twenty acres more or less  
situated in Chumville District bounded by lands belonging to John E. Williams  
Francis Edwards and Wiley Curry and represented by a letter of Con-  
veyance of the same tract of land executed by David A. Moore and William P.  
Hucke to the said Simeon Styles

and fifty two dollars and seventy five cents to us in hand paid by Simeon  
Styles of Chumville District and State of same as Receipts, Bargained, Sold  
Released and by these presents do Grant Bargain Sell and Release unto

Spartanburg District } certify unto all whom it may concern that Margaret Wright  
the wife of the within named William Wright did this day appear before me and upon being  
separately and separately examined by me did declare that she at least seven days before such  
examination (was) on the tenth day of October 1853 actually joined her husband William Wright  
in executing the within release and that the release was justly and lawfully given  
to her at least seven days before such the examination and did thus and at the  
time of the examination still does freely voluntarily and without any manner  
of compulsion dread or fear of any person whatsoever renounce release  
and forever relinquish unto the within named Simeon Styles his heirs and assigns  
all her estate interest and instances in and to the premises mentioned  
in the within release Given in due my hand and seal 18th day of October
