Allen McDavid Deed To T. Henry Stokes	South Carolina Greenville District

I Allen McDavid, Executor of the last will and testament of James McDavid late of the District and State aforesaid deceased, for and in consideration of the sum of three thousand five hundred dollars to me in hand paid by T. Henry Stokes of the said state and District, the receipt whereof I hereby acknowledge, and by virtue of my power in my testate of the last will and testament of the said James McDavid deceased, I have granted and bargained sold released and delivered to and by these presents do grant and bargain sell release and convey unto the said T. Henry Stokes, all that plantation and tract of land situate, lying and being in the District and State aforesaid on mountain or creek water of Saluda River, Beginning at a Hickory corner at spring 3 rods thence 5686 1/3 rods to Pascimmon 3 rods, thence 354 1/2 rods 20.3 rods thence 582 6 1/4 rods to Linn 3 rods, and creek, thence A 3 rods up the meanders of creek 17 rods or more 3 rods, thence 5806 4 1/2 rods to a stone 3 rods, thence 410 6 1/4 rods to stone 3 rods, thence A 76 7/15 rods to white oak dead 3 rods, thence A 10 6 7/15 rods to white oak dead 3 rods, thence A 58 2 7/41 rods to Red oak 3 rods thence A 28 4 2 7/15 rods to stake 3 rods in place of White oak gone thence A 72 6 9 rods to stone 3 rods, thence A 79 6 0 5 9 2 3 rods stone 3 rods on creek, thence A 9 1/2 rods, 5 1/4 rods to Pine 3 rods, thence 554 2 6 2 7/15 rods to the beginning, Containing six hundred acres more or less with the exception of one half acre at the graveyard. Beginning at stone on the Road 3 rods running due N. due W. due S. and due E. together with the rights of way forever. To have and to hold all and singular the premises above mentioned with the rights, members, hereditaments and appurtenances to the same belonging or in anywise incident or appertaining, unto the said T. Henry Stokes his heirs and assigns forever. And I do hereby bind myself and all the other heirs of the said plant.^d McDavid to warrant and forever defend all and singular the premises before mentioned unto the said T. Henry Stokes his heirs & assigns, against me and all others in or of the said premises McDavid deceased and against every other person or persons whomever claiming or to claim the same or any part thereof, whereby whereof I have hereunto set my hand and seal this the fourth day of August 1853
