D. Hecke In Slaves

The State of South Carolina

To all to whom these presents shall come I

Waddy Thompson of the village of Greenville in the State aforesaid send greeting Whereas I the said Waddy Thompson am indebted to David Hecke by note with D. Perry Esq. security in the sum of Two Thousand dollars with interest from the 9th day of January 1852 as in and by the said Note Relation Wherein being had doth more fully and at large appear Now Know Ye That I the said Waddy Thompson for the better securing the payment of the said sum above mentioned with the said David Hecke his executor Administrators or assigns by other with lawful interest for the same have bargained and sold and by these presents do bargain and sell and explain and give warrant deliver unto the said David Hecke the following negro slaves Hecke his wife Witty and their five children

To have and to hold the said negro slaves unto the said David Hecke his Administrators and assigns forever Provided always nevertheless That if the said Waddy Thompson his executor or Administrators shall and do will and may pay a certain sum to the said David Hecke his certain Attorney, Executors Administrators or assigns the full and just sum above mentioned according to the true intent and meaning of the note aforesaid and of these presents then this deed of bargain and sale and all and every clause article and thing therein contained shall cease determine and be utterly void and of now effect any thing herein before contained to the contrary thereof in anywise notwithstanding

And it is hereby declared barg and between the parties and the said Waddy Thompson for himself his executor Administrators and assigns doth covenant promise and agree to and with the said David Hecke his Executor Administrators and assigns by these presents that if default shall happen to be made of or in payment of the said sum above mentioned according to the true intent and meaning of the said Note then and in such case it shall and may be lawful to and for the said David Hecke his executor Administrators and assigns attorney or agents from time to time and at any times hereafter peaceably and quietly to enter into any and all the messuages lands or tenements of the said Waddy Thompson and to take the said negro slaves into his custody and possession and the same to hold and detain to his own use and behoof (as his own proper goods and chattels) from thenceforth and forever or to sell and dispose of as his will and pleasure returning his receipt if any should happen to be after paying the sum above mentioned with the said Waddy Thompson his Executor Administrators or assigns

In Witness whereof I the said Waddy Thompson have hereunto set my Hand and seal this 19th day of April in the year of our Lord one thousand eight hundred and fifty four and in the seventy eighth year of the Sovereignty and Independence of the United States of America
