Know all to whom these presents shall come that I the said John W Jones of the County of Greenville District of the State of South Carolina do hereby certify that I have given and conveyed unto the said Waddy Thompson to become my surety in the Bank of the State of South Carolina for two thousand five hundred dollars and likewise to become my surety to Samuel Henderson for one thousand dollars to James B Sherman for eleven hundred dollars and to Wallace Gooden Eight hundred dollars by notes of hand and bonds bearing interest as in and by the said notes and bonds (Relation thereto being first duly made) and at large appear

And now know ye that I the said John W Jones for the better securing the payment of the said sums above mentioned unto the said executor and assignors together with lawful interest for the same have by and carried articles and by these presents do bargain and sell and in plain and open market deliver unto the said Waddy Thompson the following slaves (viz) Dodo, Lewis, Dock, Guy, Elias, Wiley and his five children and Peggy and her two children

To have and to hold the said negro slaves above mentioned viz Dodo, Lewis, Dock, Guy, Elias, Wiley and his five children and Peggy and her two children unto the said Waddy Thompson his Executors Administrators and Assignors forever and always lawfully provided always notwithstanding that of the said John W Jones his Executors or Administrators shall die or do well and truly pay or cause to be paid unto the said Waddy Thompson my surety as of said his certain Attorney Executors, Administrators or Assignors the full and just sums above mentioned according to the true intent and meaning of the said notes and bonds aforesaid and of these presents then the heirs of the said John W Jones and all and every clause article and thing therein contained shall cease determine and be utterly void and of no effect any thing herein before contained to the contrary thereof in any wise notwithstanding

And it is hereby declared by and between the parties and the said John W Jones and his Executors, Administrators and Assignors with covenant promise and agree to and with the said Waddy Thompson his Executors, Administrators and Assignors by these presents that if default shall happen to be made of or in payment of the said sums above mentioned according to the true intent and meaning of the said obligations notes and bonds that then and in such case it shall and may be lawful to and for the said Waddy Thompson his Executors, Administrators Assignors, Attorneys or Agents from time to time and at any times hereafter peaceably and quietly to enter into any or all messuages lands or tenements of the said John W Jones and to take the above mentioned slaves into his custody and possession and the same to hold and detain to his own use and behoof (as his own proper goods and chattels) from thenceforth and forever and the same to sell and dispose of at his will and pleasure returning the couplets of any should happen to be after paying of the sums above mentioned unto the said Bank of the State, Samuel Henderson, J. B Sherman Wallace Gooden
