

Remain as follows, to wit, Beginning at stone 3, on Ashville road, thence S 75° W 4, 95 to P. O. 3, or M. thence N 45° 12' to stone 3, 3, on thence S 75° W 2, 2 to church 3, 3, or M. thence N 27° 46' 30" S 31 1/2° S, 3, 3, or M. thence S 35° 12' 77' S 3, 3, or M. thence N 69° 49, 50 to P. O. 3, 3, or M. thence N 10, W 7, 50 - R. O. 3, 3, or M. at a Branch thence up prong of said Branch to P. O. 3, 3, or M. thence N 35° E 19, 80 to W. O. 3, 3, or M. at Pau-hu-jak of Mock Creek, thence down said fork to Branch, thence up said Branch to stone 3, 3, or M. thence S 34° E to W. O. 3, 3, or M. thence S 21° 6' S 3, 3, or M. thence S 30° 11' to a small black oak 3, 3, or M. thence N 40° E 8, 12 to P. O. 3, 3, or M. thence N 10° E 2, 75 to W. O. 3, 3, or M. thence S 81° 40' E 35, 25 to Stone 3, 3, or M. at stake 3, 3, or M. thence S 44° W 40 R. O. 3, 3, or M. thence S 42° W 13, 3, 3, or M. to black oak 3, 3, or M. thence S 35° W 190 to the Beginning corner.

Together with all and singular, the rights, members, tenements and appurtenances to the said premises belonging or in anywise incident or appertaining. I have and to hold all and singular the said premises unto the said John A. Townes his Successors in office and assigns forever. And when I have so done I have hereunto set my hand and seal, and administered the oaths and sworn before me all and singular the said premises unto the said Townes of record, his Successors and assigns forever and against my heirs, executors, administrators and assigns lawfully claiming or to claim the same for any years thereof. Provided always nevertheless, and it is the true intent and meaning of the parties to these presents, that if the said John Casmay is and shall well and truly pay or cause to be paid unto the said Townes - commission as aforesaid, the said debt or sum of money of record with the interest thereon (if any shall be due) according to the true intent and meaning of the said Bond and condition therein written, then this debt of bargain and sale shall cease, determine and be utterly null and void, otherwise it shall remain in full force and virtue. And it is agreed and between the said parties, that the said Casmay is to hold and enjoy the said premises until default of payment shall be made.
