Know all men by these presents that I Waddy Thompson of Greenville District in the said State in consideration of Eighteen Thousand Dollars to me paid by James P. Joyce of the same District and State have granted bargained sold and released and by these presents do hereby grant, bargain, sell and release to the said James P. Joyce all that piece, parcel and tract of Land containing One hundred and twenty eight acres, more or less Situate lying and being in the District and State aforesaid upon both Sides of Hickland Creek waters of Reedy River and upon the South Side of the road from the Town of Greenville to the Town of Laurens, and partly within the corporate limits of the said Town of Greenville, containing Parcels of Episcopal Church of Christ Church, Cleveland and Green or Hartman and having the following boundary lines and corners viz Beginning at a Stake 3x in the middle of the said Laurens Road at the corner of said lands of Episcopal Church and running thence with middle of said Road N^E 73 6^E forty chains to a Stake at a bend in said road Thence still with middle of said road N^E 66 6^E eight chains and fifty links to a Stake at the junction of the Spartanburg road, Thence still with middle of said Laurens road S^E 74 4^W thirty chains to a Stake at bend in road Thence still with middle of said road S^E 62 6^E ten chains and eighty five links to a Stake at bend in road Thence still with middle of said road S^E 70 4^E fourteen chains and sixty five links to a Stake 3x Thence with Green or Hammonds line S^E 45 4^W thirty six chains and forty five links to a Stake 3x forming a Stone Thence with Cleveland line N^E 45 4^W twenty eight chains and Sixty five links to a B. O. 3x Thence still with Cleveland line S^E 13 4^W Twenty three chains to a Pine 3x Thence with line of S. P. C. Church land N^E 32 4^W thirteen chains and fifty links to a P. O. 3x Thence still with line of said land N^E 18 4^W eight chains to the beginning corner Together with all and singular the rights, members, fixtures and appurtenances to the said premises belonging or in any wise incident or appertaining.

To have and to hold all and singular the premises before mentioned unto the said James P. Joyce his Heirs and assigns forever And I do hereby bind myself my Heirs Executors and Administrators to warrant and furnish before all and singular the said premises unto the said James P. Joyce his Heirs and assigns against myself and my Heirs and assigns and against every other person whomever lawfully claiming at to claim the same or any part thereof.
