being the same conveyed to John Harrison by Catharine La Bruce &  
A W Campbell Executors & Administrators of the will of J P La Bruce by  
deed of 9th February 1837 Recorded in page 300 Book 5 Office of Register  
of Meigs conveyance for said District being bounded as follows. Beginning
