in the State aforesaid in consideration of the sum of Fifteen Hundred dollars to me paid by Jeremiah Whitmire of Pickens District in the State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and released unto the said Jeremiah Whitmire all that piece parcel and tract of Land lying and being in Greenville District and State aforesaid on beaver Dam Creek of Enone River Beginning at a Red oak st and running a straight line to a Black Gum at the bridge over the creek on the road thence down the creek to a conditional line made by Elias Earle and Thomas Springfield then east course to a dead oak on Thomas Hookers Spring branch thence up the main Spring branch to head, thence an east course to the back line thence S. 00. 50 to a chestnut st thence west 37 chains to a Black oak thence North 61.5. 36.6. to a red oak thence N W 15 deg 26 chains 6 links to the beginning Red Oak st being the same tract I purchased for John Moon as Executor of C Clardy will. The said tract was originally Granted to Frances Brewer and Ephraim Mitchell being a part of said Grant. The above tract containing three Hundred acres more or less. Possession to be given the first of January 1858. Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining. To have and to hold all and singular the premises before mentioned unto the said Jeremiah Whitmire his heirs and assigns forever and I do hereby bind my self my heirs Executors and administrators to warrant and forever defend all and singular the said premises unto the said Jeremiah Whitmire his heirs and assigns against me and my heirs and any person whomsoever lawfully claiming or to claim the same or any part thereof
