 or tract of land containing by Estimation fifty Acres more or less  
 situated in the State and District aforesaid on both sides of Tyger  
 River and runs as follows beginning on a conditional line made  
 between Henry Tankesley and Patsy Gilley running N 77 W to a  
 Stake thence S 70 W 30 chains to a black Gum thence S 20 E to the  
 conditional line made by Henry Tankesley & Patsy Gilley thence along
