Deed To For The State of South Carolina This indenture made the second day of October in the year of our Lord one thousand eight hundred and fifty four between Samuel A Townes Esquire Commissioner of the Honorable Court of Equity for Greenville District at Greenville Court House in the said State of the one part and Thaddeus C Bolling of the other part Whereas William T Turpin and Thomas T Turpin complainants did on or about the twenty first day of September in the year of our Lord one thousand eight hundred and fifty three exhibit their Bill of Complaint in the Court of Equity at Greenville Court House in the said State against J M A Turpin C W Dillard S C L Dillard and others praying amongst other things for a partition of the real estate of William Turpin deceased late of said District amongst his heirs at Law. And the Cause being at issue before the Honorable Court came on to be heard at July Term in the year of our Lord one thousand eight hundred and fifty four when the said Court after full hearing thereof and mature deliberation in the premises did Order Adjudge and decree that the said Real Estate of said William Turpin deceased should be sold at Public Auction by the Commissioner of the said Court on the terms and for the purposes mentioned in their Decretal Order as by reference thereto in the Registry of the said Court will appear And the said Samuel A Townes Esquire as Commissioner of the said
