 and personal which the said Emma shall or may hereafter acq  
 uire whether by inheritance purchase gift grant devise or bequest  
 or in any other way or manner whatsoever shall be conveyed unto  
 Thomas R Rhodes of the County of Richmond and State of Georgia in trust  
 for the uses and purposes and upon the limitations and conditions herein  
 after set forth and declared the full and free consent of the said Foster  
 thereto and the acceptance of the trust, hereby and herein granted  
 by the said Thomas R. being signified by his signing and sealing these  
 presents. Now therefore this indenture tripartite, had made and concluded  
 on the nineteenth day of December in the year of our Lord one thousand  
 eight hundred and fifty nine between the said Emma of the first part  
 the said Foster of the second part. and the said Thomas R. of the third  
 part. Witnesseth that the said Emma by and with the consent and  
 approbation of the said Foster signified as aforesaid, in consideration  
 of the marriage to be had and solemnized as aforementioned, as well  
 as for and in consideration of the sum of Ten dollars to her in hand  
 paid by the said Thomas R. at and before the execution of these presents  
 hath given granted bargained, sold aliened conveyed and confirmed and by  
 these presents doth give grant bargain sell alien convey and confirm  
 unto the said Thomas R. his heirs and assigns and successors in the trust  
 all that property real and personal of what kind soever bonds notes and other  
 evidences of debt to which he may hereafter become entitled either by gift  
 grant purchase inheritance or otherwise during the coverture, to  
 have and to hold all and singular the aforesaid property of every  
 kind and description unto him the said Thomas R. his heirs and assigns  
 and successors in the trust in fee simple forever subject nevertheless  
 to the following trusts uses limitations and conditions that is to say  
 In Trust for the mutual support maintenance comfort use and  
 behoof of the said Foster and Emma during during their joint lives  
 and in the event of the said Emma surviving the said Foster then  
 in trust for her the said Emma and her children, and in the  
 event of the said Emma leaving child or children living at her  
 death whether the same occur before or after the death of the said  
 Foster then in trust for such child or children her surviving But  
 should the said Emma die without child or children surviving her  
 whether she die before or after the said Foster then in trust to be dispo  
 sed of as she the said Emma by her last will and Testament or  
 otherwise may direct which said power of disposition by will or otherwise  
 is hereby expressly reserved to her in the event of her dying without  
 child or children surviving her and in trust that the said Thomas R.  
 shall and will permit the said Foster to possess and control the said  
 property real and personal during the joint lives of the said Foster and  
 the said Emma provided he shall keep and preserve the same free
