

Robt McKay 0.9.0 Deed State of South Carolina Greenville District

To Alex M Kinney Land this Indenture made this 10th day of May in the year of our Lord One thousand eight hundred and sixty between Robert McKay Ordinary of the District aforesaid and Alexander M Kinney of the same State and District Whereas a writ of Summons to divide or sell a certain Tract of Land hereinafter described of the estate of Amos Tankasley of said District deceased issued from the Court of Ordinary of said District and upon the return thereof the Judge of said Court did determine that the said Land could not be divided without injury to the parties interested and did order the same to be sold by the Sheriff of the District aforesaid on a credit of twelve months with interest from the day of sale, Whereupon the Sheriff aforesaid did advertise the said Land for sale on the first Monday in May in the year above mentioned, and whereas the Sheriff aforesaid did on the said day, expose to sale, at public outcry, on the credit aforesaid, the said Land when the said Alexander M Kinney was the last and highest bidder, to whom the said Land was struck off for the sum of Two Hundred Dollars. Now this indenture witnesseth that in consideration of the sum of Two Hundred Dollars to me paid and secured to be paid I have granted bargained, sold and released and by these presents do grant bargain sell and release unto the said Alexander M Kinney and his heirs and assigns all that Tract of Land situated in said District on waters of Tyger River adjoining Lands of James W Hodges Jeremiah Hamble and others and containing Two Hundred acres more or less, Together with all the appurtenances thereunto belonging, and all the estate right title interest claim or demand which the said Amos Tankasley deceased, at the time of his death had in or to the same, So have and to hold the said Tract of Land together with all and singular the premises improvements and appurtenances to the said Alexander M Kinney his heirs and assigns forever

One thousand eight hundred and fifty nine between Robert McKay Ordinary of the District aforesaid, and W A Hammett of the same State and District Whereas a writ of Summons to divide or sell a certain Tract of Land hereinafter described of the estate of Thomas Hammett of said District deceased issued from the Court of Ordinary of said District and upon the return thereof, the Judges of said Court did determine that the said Land could be divided without injury to the parties interested, and did order the same to be sold by the Sheriff of the District aforesaid on a credit of Twelve months with interest from the day of sale Whereas the Sheriff aforesaid did advertise the said Land for sale on the first Monday in October in the year above mentioned and whereas the Sheriff aforesaid did on the said day expose to sale, at public outcry on the credit aforesaid the said Land when the said W A Hammett was the last and highest bidder to whom the said Land was struck off for the sum of Twelve Hundred and Ten Dollars, Now this Indenture witnesseth that in consideration of the sum of Twelve Hundred and Ten dollars to me paid and secured to be paid I have granted bargained, sold and released, and by these presents do grant bargain sell and release unto the said W A Hammett and his heirs and assigns forever, all that Tract of Land situated in said District on waters of Snow River adjoining Land of Elizabeth Hammett Joseph James and others and containing One Hundred and Forty acres more or less sold for Partition amongst the heirs Together with all and the appurtenances thereunto belonging, and all the estate right title interest claim or demand which the said Thomas Hammett deceased at the time of his death had in or to the same, So have and to hold the said Tract of Land together with all and singular the premises improvements and appurtenances to the said W A Hammett his heirs and assigns forever
