Know all men by these presents that Cleanor Shelton of the State and District aforesaid for the consideration of nine hundred and ten dollars to me in hand paid or secured to be paid by Marshall Shelton of the said District and State aforesaid have granted bargained and sold and by these presents do grant bargain and sell unto the said Marshall Shelton and his heirs one tract of land containing one hundred and thirty acres of land be the same more or less bounded as follows, viz, beginning at a white oak corner on a branch the waters of Enoker River on widow Newbys and H C Lynch line thence down said branch to a poplar stump H C Lynch line thence with sd line to a stake corner on Shelton's Spring branch thence with P Lynchs line to an old road cornering on a stake J M A Turpins line thence along the old road to a white oak corner on the latter
