

D Hoke S.G.D Deed *The State of South Carolina*
 To *Thomas & McDaniel* For *Land* To all whom these presents shall come
H D Hoke Sheriff of Greenville District and State aforesaid send greeting

When as by virtue of a Writ of *Hieri Facias* issued out of the Court of Common Pleas held for the District of Greenville tested the twenty ninth day of October in the year of our Lord one thousand eight hundred and fifty nine at the suit of *B F Mauldin* survivor vs *Stephen H Long* Administrator of *Hardy Carter* Deceased to me directed, commanding me that of the goods and chattels lands and tenements of *Hardy Carter* deceased to levy the sum of Two hundred & eighteen dollars and nineteen cents damages and cost I have seized and taken of the lands and tenements of the said *Hardy Carter* deceased, all that certain piece parcel and tract of land containing One hundred and eighty more or less acres situate and being in the District of Greenville and State aforesaid on *Oil Camp Creek* adjoining lands of *Solomon Jones Cleveland* and others, and when as the said premises ^{with their appurtenances} since the seizure by me made by virtue of the said writ of *Hieri Facias* before mentioned have been exposed to sale at public vendue and purchased by *William Mc Thomas* and *W A McDaniel* of the District of Greenville for the sum of One hundred dollars being the highest sum that was bid therefor. Now know ye that *I D Hoke* Sheriff aforesaid by virtue of the said writ of *Hieri Facias* aforesaid to me directed and demanded as aforesaid and by virtue of the Statute in such cases made and provided and for and in consideration of the sum of one hundred Dollars to me in hand paid or secured to be paid by the said *William Mc Thomas* & *W A McDaniel* the receipt and payment whereof I do hereby acknowledge have granted bargained and sold and by these presents do grant bargain and sell unto the said *W Mc Thomas* & *W A McDaniel* heirs and assigns forever the said tract piece and parcel of land with its appurtenances and all the estate right title and interest which the said *Hardy Carter* of right had of in and to the same, to have and to hold the said piece parcel and tract of land with its appurtenances unto the said *W Mc Thomas* & *W A McDaniel* their heirs and assigns forever as fully and absolutely as I the said *D Hoke* might could or ought to grant bargain and sell the same by virtue of the Statute aforesaid and the said writ of *Hieri Facias* or otherwise. In witness whereof I the said *D Hoke* have hereunto set my hand and seal the sixth day of February in the year of our Lord one thousand eight hundred & sixty signed sealed & delivered in presence of *I B Thompson* & *F Gossett* *S.G.D*

 To *B Howard* For *Land* Know all men by these presents
 that *I Moses W Finger* of Greenville in the State aforesaid in consideration

of the sum of Twenty four hundred Dollars to me paid by *Batte Howard* of *Edgefield District* in the State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said *Batte Howard* all that piece parcel and lot of land situate lying and being in the corporate limits of the Town of Greenville on the North side of the Pendleton Road being a back lot adjoining *Mrs Mcalls* land and *Varday McBees* land beginning at a stake & corner of a street 60 ft wide and runs thence along said street N 22 W 394 feet to a stake & thence with said *McBees* line S 68 W 394 feet to a stake & thence with *Mrs Mcalls* line S 22 E 394 feet to a stake & on a street 50 ft wide thence N 68 E 394 feet to the beginning containing three acres & two rods more or less. Together with all and singular the rights members hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. To have and to hold all and singular the premises before mentioned unto the said *Batte Howard* his heirs and assigns forever and I do hereby bind myself my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said *Batte Howard* his heirs and assigns against me and my heirs and any other person or persons whomsoever lawfully claiming or to claim the same or any part thereof. Witness my hand and seal this 8th day of February in the year of our Lord one thousand eight hundred and fifty six and in the eighteenth year of the independence of the United States of America.
