 To Greenville District  
 A Burnett for Land Know all men by these presents that

I Morris Gosnell of the State and  
 Dist aforesaid am have this day bargained sold and by these presents  
 do grant bargain sell and convey a certain tract or parcel of  
 land lying in Dist aforesaid on the waters of Saluda for and in  
 consideration of the sum of Two Hundred and fifty Dollars to me paid  
 by Aron Burnett for Mary A Hampton the receipt of which is hereby  
 acknowledged do grant bargain sell and convey the said tract of  
 land unto Mary A Hampton or her heirs. beginning on a stake on  
 the line of which there is a station & which is between a chestnut  
 corner and a pine corner and running a conditional line made  
 by Berry & Sherod Gosnell to a white oak a conditional corner  
 thence a long the conditional marked line to the out line thence  
 $N 23^{\circ} 8'$  to a Hickory corner thence  $N 10^{\circ} W 7.50$  to a Hickory thence  $N$   
 $44^{\circ} E 8'$  across the branch to a Hickory thence  $N 13^{\circ} E 11.50$  to a B gum  
 thence  $E 11'$  to a oak thence  $11.2^{\circ} E 10'$  ch to a chestnut thence  $S 40^{\circ} S 11-$   
 $50$  to a poplar thence  $S 79^{\circ} E 10'$  to a poplar thence  $S 40^{\circ} W 17'$  to a chestnut  
 thence  $S 10^{\circ} W$  by a oak stake to the beginning containing about One  
 Hundred and fifty acres more or less. Together I Morris Gosnell do  
 hereby bind my self my heirs executors and administrators to and  
 forever defend the above named tract of land to Mary A Hampton  
 or her heirs and assigns Against my self my heirs executors adnrs to  
 warrant and forever defend the above named premises hereditaments  
 and appurtenances belonging or in anywise incident to the said Mary  
 A Hampton his heirs and assigns against any and every other  
 person or persons claiming or attempting to claim the same or  
 any part thereof On Testimony whereof I have hereunto set my  
 hand and affixed my seal this 20 January one thousand eight
