 So Greenville District 3 these presents that  
 Fork Shoal Church Land we James Garrison and Sally Berry  
 of the State and district aforesaid the  
 Heirs of Majs Micajah Berry deceased late of the said  
 State and District aforesaid for and in consideration of the  
 sum of one dollar or to us in hand paid and furthermore being  
 thence to moved by other good and sufficient reasons have  
 granted bargained sold and released and by these presents do grant  
 bargain sell release and convey to the Fork Shoal Baptist Church  
 all that parcel or tract of land, lying in the state and district  
 aforesaid and adjoining lands of said church and having the  
 following marks & boundaries Viz. begining on a Post oak 3+ on the  
 south side of Fork Shoal Road Dr Moores & Church lot corner and  
 running thence S66 E 5.60 to a Rock 3+ newly made on Dr Moores  
 line thence S46 W 6.07 to a Cedar Bush 3+ nm thence N88 W 7.17  
 to a Rock 3+ on the north side of Fork Shoal Road thence along  
 said road N56 E to the begining bounded by lands of Fork Shoal  
 church Dr D D Moon and Heirs of M Berry deceased and  
 containing Four Acres be the same more or less, the same being  
 part of a tract originally granted to Abner Bishop and passing  
 through the hands of Daniel Ford McElroy and Fowler, to the  
 said M Berry deceased. Together with all and singular the  
 rights members hereditaments and appurtenances to the same  
 belonging or in any wise incident or appertaining, to have  
 and to hold, all and singular the premises above descri-  
 bed and conveyed to the Fork Shoal Baptist Church  
 and its assigns forever, and we do hereby bind ourselves  
 our heirs executors & administrators to warrant and forever  
 defend all and singular the above described premises to  
 the said Fork Shoal Baptist Church and its assigns  
 against ourselves our heirs and assigns every other  
 person whosoever lawfully claiming or to claim the  
 same or any part thereof.
