Know all men by these presents that I John W Baker one of the executors of James Alexander deceased for and in the consideration of Nine Hundred and Sixty Dollars to me in hand paid by John Anderson, I have caused to be sold at public auction the plantation whereon James Alexander decd formerly lived and bargained sold and released and by these presents do grant bargain sell & release all that part containing 152 acres more or less it being a part of a tract of land granted to Sa^d Alexander containing 352 acres certified the 30th day of August 1784 recorded in Book D D D page 400 beginning at a Rock 3+ on a road & along the road S 12 W 18 1/2 to a Rock 3+ thence S 9 E 17 to a Rock 3+ & runs S 33 W 29 1/2 to St 3+ & S 59 E 11 1/2 to St branch & S 35 E 7 1/2 & S 84 E 44 1/2 to a Dogwood or Rock 3+ & N 10 W 19 to a W. O Stamp 3+ & up the branch N 86 W 22 1/2 to a bend & N 13 W 24 & N 3 E 6 1/4 & N 67 W 14 to the beginning, with all and singular the above described piece of land containing 152. acres more or less with all the profits thereunto belonging, and I the S^d John W Baker do hereby bind my self my heirs Exec^t & assigns to warrant & forever defend the above described piece of land unto the S^d John Anderson his heirs & assigns to have & to hold with all the hereditaments thereunto appertaining or in anywise incident or belonging to the S^d premises and I the S^d John W Baker do hereby bind my self & assigns to defend the S^d tract of land unto the said John Anderson & assigns against any person or persons lawfully claiming the same or any part thereof. In witness whereof I have set my hand & seal this 2^d day of January 1862 And in the 85 year of the confederate States of America Independence
