 life Estate in the Said Tract of land unto the Said John S
 Ashmon his Executors administrators and assigns for ever
 upon such Trusts nevertheless and to and for such uses intents
 and purposes are hereinafter expressed and declared of & concerning
 the same that is to say, In Trust for the Said Emilia E Green
 her executors administrators and assigns until the solemnization
 of the Said intended marriage and from and immediately after
 the solemnization thereof then, In Trust that the Said John S Ashmon
 has Executors administrators and assigns do and shall permit and
 suffer the Said George S Houghs during the joint lives of himself
 and the Said Emilia E Green his intended wife to have the occupa-
 -tion enjoyment direction and management of the Said negro slaves
 and the future issue and increase of the Females, Together with the
 other property above mentioned, but so as the same shall not in
 any manner be liable to his debts contracts or Engagements and
 to receive and take the profits proceeds emoluments and advantages
 of their work & labor for their joint use and benefit, and in case
 the Said Emilia E Green Should survive the Said George S Houghs
 her intended husband then, In Trust that the Said John S Ashmon
 his Executors administrators & assigns do grant convey assign and
 transfer all the Said Seven negro slaves and the future issue & increase
 of the females, Together with the remainder of the property above
 mentioned & the life Estate in the Said tract of land unto the Said
 Emilia E Green her executors administrators and assigns absolutely
 forever freed and discharged of and from all other & future trust
 but if it shall happen that the George S Houghs Should survive
 the Said Emilia E Green his intended wife then In trust that the
 Said John S Ashmon his executors administrators and assigns
 do grant convey assign and transfer all and singular the Said
 negro slaves, Together with the remainder of the property above
 mentioned & the future issue and increase of the female slaves
 to the issue of her body lawfully begotten freed from all others
 & further trust to them & their heirs forever, and it is further
 covenanted and agreed by and between the parties that the Said
 Emilia E Green for and in consideration of the premises doth renounce
 release & forever relinquish all her interest and claim of Dower of
 in or to the property of the Said George S Houghs to which she
 may be entitled by reason of the Said intended marriage
 In witness whereof the parties aforesaid to these presents have
 hereunto set their hands and seals dated the day & year above
 written, Interlined before Execution.]
