Know all men by these presents that I John W Plumley of the State & District aforesaid have this day bargained sold and by these presents do grant bargain sell and convey a certain tract or parcel of Land lying in said District on the waters of Saluda River for an inconsideration of the sum of Five Hundred and Seventy One dollars to me paid by W M Plumley & Moses C Plumley of the same State & District the receipt of which is hereby acknowledged It being a tract of Land granted to Richard Brazile dated 7<sup>th</sup> Sept 1793 and to me by Jesse Center Beginning on a Poplar thence N 39 W 9 to a Hickory thence N 60 W 12 to a Pine thence N 23 E 6 to a Forked Maple thence N 33 W to a stake thence N 57 W 10 to a stake N 33 W 10 to a stake thence S 57 E 10 to a Locust thence S 45 W 50 to a chestnut thence S 77 W 20 to a chestnut thence S 45 W 13.50 to a Hickory thence S 52 E 25 to a stake thence S 80 E 17 to a stake thence N 65 E 3.5 to the beginning Poplar containing Two Hundred acres be the same more or less. and I do hereby bind my self my heirs Executors and administrators to warrant and for ever defend the above named tract of land to the said W M Plumley and Moses C Plumley or their heirs and assigns against my self my heirs executors & administrators to warrant and for ever defend the above named premises hereditaments & appurtenances belonging or in any wise incident to the said W M Plumley & Moses C Plumley their heirs and assigns against my self & my heirs for ever In witness whereof I have hereunto set my hand & seal this 16<sup>th</sup> day of March A D 1863.
