 parcel of Land situate and being in the District and State  
 aforesaid on both sides of Frawhawk Creek of South Tyger  
 River, Beginning at a Stake 3+ thence West 7.25 to a Stone 3+  
 thence North 26 00 to a Stone 3+ Red Oak down thence S 72 1/2  
 W 24.00 to a Pine 3+ dead and down thence S 17 3/4 E 32.00 to a White  
 Oak 3+ 3+ thence S 85 1/2 E 2.25 to a Red oak 3+ thence N 63 E 2.70 to  
 a White oak 3+ dead, thence S 81 1/2 E 5.90 to a Maple 3+ on a Creek  
 thence up the creek 4.25 to a white Oak Stump 3+ thence S 30 1/2 E 18.43  
 to the beginning containing ninety and one fourth acres more or
