 J D Parkins              Land                          that in pursuance of directions  
 and authority to me for the  
 purposes given and by the last will and Testament of  
 Martha H Ashmon deceased I James H Ashmon as executor  
 of the said last will and Testament in the State aforesaid  
 for and in consideration of the sum of Eighty Dollars  
 to me paid by J D Parkins of Greenville District in the  
 State aforesaid have granted bargained sold and released  
 and by these presents do grant bargain sell and release  
 unto the said J D Parkins all that certain piece parcel  
 and tract of land lying and being in Greenville District  
 & State aforesaid on the waters of Reedy River adjoining  
 lands of John J Farmer et al and hath bounds & shapes  
 as follows. To wit begining at a Stake 3<sup>4</sup> on the road leading  
 to McBees factory thence S 37 W 22.90 chs to a Black Gum 3<sup>4</sup>  
 near McKenzies road thence N 39 W 4.80 chs to a Stake 3<sup>4</sup> thence  
 S 63 W 1.07 to a Stake 3<sup>4</sup> 0 m the aforesaid road thence N 63 W.  
 on said road 13.40 chs to Stake at the place the Factory  
 Road crosses near J Farmers residence hence along the  
 Factory road N 32 E 4.50 chs to a Stake at head of road thence  
 N 51 E 8<sup>8</sup> chs to a Stake at another bend of road thence N 66  
 E 6 chs to a bend of road, thence N 67 E 3.30 chs to the  
 begining corner containing Twenty and one half acres  
 together with all and singular the rights members hereditaments  
 and appurtenances to the said premises belonging or in any  
 wise incident or appertaining to have and to hold all  
 and singular the premises before mentioned unto the said  
 J D Parkins his heirs and assigns forever. And I do hereby  
 bind myself as Executor his Executors and administrators  
 to warrant and forever defend all and singular the said  
 premises unto the said J D Parkins his heirs and assigns  
 against me and my heirs as Executors lawfully claiming  
 or to claim the same or any part thereof
