The State of South Carolina know all men by these presents that I J D Parkins of Greenville District in the State aforesaid in consideration of the sum of One Hundred and Ninety five Dollars to me paid by James H Ashmon of Greenville District in the State aforesaid have granted bargained sold and released and by these presents do grant bargain sell and release unto the said James H Ashmon all that certain piece parcel and tract of Land lying and being in Greenville District and State aforesaid on the head waters of Reedy fork adjoining lands of J J Farmer and E Bramlett and others begining at a Stake  $\frac{3}{4}$  on the road leading to McBees Factory thence S 30 W 22.90 chs to a black gum  $\frac{3}{4}$  near McKenrys road thence N 39 W 4.80 chs to a Stake  $\frac{3}{4}$  thence S 63 W 1.07 to a Stake  $\frac{3}{4}$  on the aforesaid road thence N 63 W on said road 13.40 chs to Stake at the place the factory road crosses near J J Farmer residence thence along the factory road N 32 E 4.50 chs to a Stake at bend of road thence N 51 E 8 chs to a Stake at another bend of road thence N 60 E 6 chs to bend of road thence N 67 E 3.30 to the begining corner containing Twenty and one half acres more or less, together with all and singular the rights, members hereditaments and appurtenances to the said premises belonging or in any wise incident or appertaining, To have and to hold all and singular the premises before mentioned unto the said James H Ashmon his heirs and assigns forever, And I do hereby bind my self my heirs executors and administrators to warrant and forever defend all and singular the said premises unto the said James H Ashmon his heirs and assigns against me and my heirs and every other person whomsoever lawfully claiming or to claim the same or any part thereof, Witness my hand and seal this 25<sup>th</sup> day of April in the year of our Lord one thousand eight hundred and sixty three and in the 87<sup>th</sup> year of the independence of the Confederate States of America, Sealed sealed and delivered in the presence of J T McDaniel W A McDaniel  $\frac{3}{3}$
