Know all men by these presents that I John Crittenden in the State and District aforesaid in consideration of the sum of Six thousand One thirty Dollars to me paid by George M Chaplin of the same State and District have granted bargained sold and released and by these presents do grant bargain sell and release unto the said George M Chaplin all that tract and parcel of land, Situate lying and being in the District of Greenville and State aforesaid on the waters of Richland Creek and on both sides of the road leading to Rutherford North Carolina and containing three hundred and one 1/2 acres more or less and bounded as follows beginning at a stake on the order Thompsons line at the base of the hill on the South side of the Creek running thence North 50 Chances 50 Links to a Stake near a Spring thence East 50 Links to a Stake thence N 5 W 6.50 links to a Sweet Gum near the road thence S 71 W 5 chains with the road to a Stake on old line 3+ thence with the old line N 10 E 36 chains to a Post oak 3+ thence west 30 chains to a Stake thence S 30 W 45 chs to a Stake thence S 70 E 27 chs 50 links to a Stake 3+ thence S 11 E 11 chains to Stake thence S 45 W 7 chains 70 Links to a Pass afros 3+ thence S 40 E 5 to Stake thence S 6 W 2 chains 69 Links to Stake thence S 25 E 4 chs 85 Lk to Stake 3+ thence S 3 E 7 chains to Thompsons line at the base of the hill thence S 85 E 15 chains to the base of the hill thence S 45 E 13 chains 50 links to Stake thence N 55 E 2 chains to the beginning It being part of a tract of land I bought of Jeremiah Cleveland by deed bearing date the thirteenth day of October 1839.
