 To For Know all men by these presents  
 Charles L Davis Land & Co that I A W G Davis one of the  
 firm of Hodges Davis & Davis  
 known as the firm of Hodges Davis & Company of  
 Greenville District in the State aforesaid in consider-  
 ation of One Dollar as to me cash in hand paid & Thirty  
 Five hundred Dollars by way of advancements from  
 father to son to me paid by Charles L Davis of Green-  
 ville District in the State aforesaid have granted han-  
 garded sold and released and by these presents do grant  
 Bargain sell unto the said Charles L Davis one  $\frac{1}{6}$  alf.  
 part  $\frac{1}{8}$  of all my interest in and to all and singular  
 in Twenty five acres of land more or less, wherein the Tan  
 yard and Shoe factory is now established in Greenville  
 District for particulars see deed from I Hodges & B Davis  
 and W J Davis to me for particulars dated 28 May 1863 also  
 one Eighth part  $\frac{1}{8}$  of Three Hundred and Twenty five acres  
 of land Less fifteen acres more or less, deeded to me by  
 Alexander McBee & Recorded in Book 3 Page 590. See particu-  
 lars of Deed also one Eighth part in and to the Tan  
 yard Shoe Factory and Machinery now on the premises  
 and one Eighth part of all the Stock Intrade and all  
 other things pertaining to the partnership except the  
 many now due the Said Davis for previous transaction  
 Together with all and singular the rights members hereditament  
 and appurtenances to the said premises belonging or in any  
 wise incident or appertaining, To have and to hold all  
 and singular the premises before mentioned unto the said  
 Charles L Davis his heirs and assigns forever, and I do  
 hereby bind my self my heirs executors and administrators  
 to warrant and forever defend all and singular the said  
 Charles L Davis his heirs and assigns against me and my  
 heirs and every other person whosoever lawfully claiming  
 or to claim the same or any part thereof
