 This indenture made the seventh
 day of September in the year of

our Lord one thousand eight hundred and sixty three between
 William Mc Thomas Esquire commissioner of the Honorable
 court of Equity for Greenville District at Greenville Court House
 in the said State of the one part and William Mc Thomas of
 the other part. Whereas William Mc Thomas administrator of
 all and singular the goods and chattes rights and credits which
 were of Joseph A Legion deceased with the will annexed, on
 or about the Twenty fifth day of May in the year of our Lord
 one thousand eight hundred and sixty three exhibited his bill of
 complaint in the Court of Equity at Greenville Court House in
 the said State against Nancy A Legion and others legatees
 under said will for the sale of the land bequeathed specifically
 in said will in aid and assistance of said Legions personal
 estate for the payment of the debts, and the cause being at issue
 before the Honorable Court came on to be heard at July Term in the
 year of our Lord one thousand eight hundred and sixty three when
 the said Court, after full hearing thereof and mature deliberation in the
 premises did order adjudge and decree that said land should be sold
 at public auction by the commissioner of the said Court on the
 terms and for the purposes mentioned in their decretal order as
 by reference thereto in the registry of the said Court will appear
 and the said William Mc Thomas as commissioner of the said
 Court after having duly advertised the said Land for sale by
 public outcry on the seventh day of September in the year of
 our Lord one thousand eight hundred and sixty three did then
 openly and publicly, and according to the custom of Auctions
 sell and dispose of the said Land below described unto the
 said William Mc Thomas for three thousand two hundred and
 Twenty Seven doll ars being at that price the highest bidder
 for the same. Now therefore this indenture witnesseth, that the
 said William Mc Thomas as commissioner of the said Court under
 and by virtue of the said Decree and in consideration of the sum
 of three thousand two hundred and twenty seven dollars paid him
 by the said Wm Mc Thomas the receipt whereof is hereby acknowledge
 hath granted bargained sold and released and by these presents do
 doth grant bargain sell and release unto the said William
 Mc Thomas and his heirs and assigns all that tract or parcel
 of Land situate lying and being in Greenville District of Enoree
