 Know all men by these presents  
 that I Clarinda McCullough

of Greenville District in the State aforesaid for and in consid-  
 eration of the sum of Six thousand Dollars to me paid by  
 David Lopez of the City of Charleston in the State aforesaid  
 as Trustee have granted bargain sold and released and by these  
 presents do grant bargain sell and release unto the said David  
 Lopez as Trustee the house and lot situated in the fork of the  
 Anderson and Pendleton Roads Lot No 1 & 2 beginning near  
 the fork of said road and running thence S 31<sup>o</sup> W 414 feet to  
 Stake 3+ on a crop Street 60 feet wide thence along said Street  
 N 74<sup>o</sup> W 282 feet to a Stake on a Street 60 feet wide thence with  
 said Street N 16<sup>o</sup> E 400 feet to a Stake 3+ on Pendleton Street  
 thence with said Street S 74<sup>o</sup> E 390 feet to the beginning corner  
 containing three acres and fifteen Poles, the same more or less  
 the above premises being and lying in the corporate limits  
 of the Town of Greenville three fourths of a mile from the  
 Court House conveyed to me by Vardry McBee by plat  
 attached to 16<sup>th</sup> W Pasby. Together with all and singular the  
 rights members hereditaments and appurtenances to the said  
 premises belonging or in any wise incident or appertaining  
 to have and to hold all and singular the premises before  
 mentioned unto the said David Lopez Trustee his heirs  
 and assigns forever, and I do hereby bind my self my heirs  
 executors and administrators to warrant and forever defend  
 all and singular the said premises unto the said David  
 Lopez Trustee his heirs and assigns against me and my  
 heirs or any person whomsoever lawfully claiming or  
 to claim the same or any part thereof
