 these presents do grant bargain sell and release unto  
 the said H A Miles his heirs & assigns, all that piece part  
 or tract of land known as the Hightower old place whereon  
 Rebecca Barton has resided since the death of her former  
 husband John Hightower situate lying and being in Greenville  
 on Beaver Dam Creek waters of North Saluda containing  
 five hundred and seventy six acres more or less, bounded  
 by lands of W W Hedges John Gosnell Lands belonging to  
 the Estate of Alfred Cantrell and others compassed of  
 several smaller tracts of land, and conveyed by the Comm-  
 issioner in Equity to the said Rebecca Barton sixth day  
 of October A D 1845. Together with all and singular the  
 rights members hereditaments and appurtenances to the  
 said premises belonging or in anywise incident or appertain-  
 ing. To have and to hold all and singular the premises  
 before mentioned unto the said H A Miles his heirs and assigns  
 forever, and I as Trustee do hereby bind myself my heirs  
 Executors and administrators to warrant and forever defend  
 all and singular the said premises unto the said H A Miles  
 his heirs and assigns against myself and my heirs and  
 all other persons lawfully claiming or to claim the same  
 or any part thereof
